

### CALL FOR ABSTRACTS

### VII Fichte Congress of the Latin American Fichte Society (ALEF).



"The doctrine of science and its displacements"



Continuing its efforts to discuss, analyse and understand the work of Johann Gottlieb Fichte, the Latin American Fichte Society (ALEF) announces its 7th Congress, to be held in São Carlos, Brazil, at the Federal University of São Carlos (UFSCar), between 5 and 7 November this year. The central theme of the Congress is "The doctrine of science and its displacements". With this theme, we aim to debate a mechanism and even a central motif of the doctrine of science, both from a systematic and historical point of view. Firstly, because the doctrine of science itself was born from a certain interpretation and - some might say - a certain displacement of Kantian transcendental philosophy. Secondly, because Fichte's philosophy has historically been presented in different versions, which, never identical, have always meant for both author and reader an expository and even doctrinal shift. Historically, it was also the reception of the doctrine of science that, under the reading of its immediate readers - Schelling, Hegel, the Romantics, Jacobi... -, later readers - Lask, Husserl, Henry, Richir... - and current ones,

has been reordered according to different speculative interests, generally alien to its original motives - it is therefore displaced. And even the fact that Fichte, a German-speaking author from the 18th and 19th century, is being discussed today in America, in Brazil, does not fail to signify a certain displacement, the understanding of which is our task - and with this last aspect we intend to continue the very rich discussions that took place at our last congress in Buenos Aires, whose theme was precisely "Fichte in the Americas". But, finally, one has to ask whether "displacement" isn't a systematic motif of the doctrine of science itself, designating a mechanism that constitutes all human knowledge in general, that of the passage - or displacement - from the supersensible to the sensible. The Congress will also be the occasion for a tribute to Rubens Rodrigues Torres Filho, a pioneer in studies on Fichte and classical German philosophy in Brazil, who left us at the end of 2023.

It is with joy, then, that the 7th ALEF Congress invites everyone to communicate the results of their research and enrich the understanding of Fichtian thought and classical German philosophy in general.

- This will be an in-person meeting (no possibility of participating on-line).

- Communications will have between 25 and 30 minutes, followed by 15 minutes of discussion.
